#### **Understand the Context:**

Pro Bono Ontario at a Glance

**Structure:** A registered charity with no government funding, entirely dependent on private donations and grants.

<u>Vision</u>: A community that harnesses the resources of lawyers, law firms, legal departments and law associations to address the unmet legal needs affecting low-income Ontarians' ability to lead secure, healthy and productive lives.

<u>Mission</u>: To bridge the gap between lawyers who want to donate services and low-income Ontarians who cannot afford a lawyer.






